- ▶ Green Card (I-551 Permanent Resident Card)
- ▶ 5 year residence, employment, and school history
- ▶ Marriage history and/or children's information\* (full name, DOB, address, immigration status, alien number)
- ▶ Criminal history\* (arrests, citation, charges and/or conviction regardless of the case result)
- ▶ State-issued identification, Social Security number, and passport(s)
- ▶ Information about recent trips outside the United States and Canada
- ▶ Most recent income tax documents including W2, and/or proof of public assistance (e.g. Food Stamps, Medicaid, SSI)
