1. Wang Ji Thong Family Scholarship -

Scholarship recipients are determined by a selection committee made up of two donors and one former ASIA employee who retired from managing the youth programming. Recipients must complete a day of shadowing at the clinic to receive their scholarship check, made out directly to them, in addition to submitting a professional photo and some video recordings of them answering questions about their aspirations and motivations for future scholarship promotions. We acquire a Form W9 from each of them. They are eligible to receive a book scholarship one year from their initial award after they have submitted a one-page summary essay of what they've achieved in the previous year since receiving the scholarship.

2. Aiming Higher Scholarship -

Scholarship recipients are determined by a selection committee made up of two donors, two community members, and one former CEO and founder of ASIA. Recipients must submit a professional photo and complete a Form W9. Scholarship checks are made out to the educational institution in which they are enrolled with a valid student ID number, sent directly to the Bursar's offices.
